## 2025 ART CONTEST ENTRY FORM

I desire to participate in a poster contest (the "Contest") organized and conducted by Purdue University and its Purdue Center for Economic Education (collectively, "Purdue" or "PCEE"). In consideration of permission granted by Purdue to allow me to participate in the Contest, I (together with my parent or guardian, if I am under the age of eighteen or under a legal disability) (sometimes referred to collectively as "Participant" below) represent, covenant and agree, on behalf of myself and my heirs, assigns, and any other person claiming by, under or through me, as follows:

The submitted entry is my original, unpublished, and previously unproduced work. If any element of my entry infringes upon the rights of another person or other entity, the entry will be disqualified from the content.

After a submission is submitted to the PCEE, Participant hereby agrees it may be made available for viewing on the PCEE website and social media sites. By participating in the Contest, Participant grants Purdue the right to use such Participant's name, photo, biographical information, and publication of artwork in all media for advertising and promotional purposes, as well as on the website or future contests. By participating in the contest, Participant also grants Purdue the right to use such Participant's name, address, and email address to contact entrant, Participant's guardian, and Participant's teacher regarding the Contest. Participant also grants Purdue University a perpetual, non-exclusive, royalty-free, sublicensable license to access and use the submission for any commercial or non-commercial purpose which Purdue University may deem appropriate at its sole discretion.

No substitutions or new versions of my entry will be accepted under any circumstances once the original entry is submitted for consideration. Any entry that is considered by PCEE at its sole and absolute discretion to be objectionable, in whole or in part, will be disqualified and will not be eligible for entry. Except as otherwise stated in these Official Rules, personal information collected online in connection with this contest will be used in accordance with university privacy and with the consent given by entrant's parents or guardians at the time of entry. Any communication or information transmitted to PCEE and/or the website by email or otherwise is and will be treated as nonconfidential and nonproprietary. PCEE will use the personal information collected for this contest to identify the winners and winners' schools, and, with permission, announce the winners.

PCEE will post only the first name, last initial, age, school, hometown, and photo of entrants with their art on the website, social media sites, and in our publications or promotional items.

PCEE may post the first name, last name, age, school, hometown, photo, and short bio of each first-, second, and third-place winner for newsletters.

I agree my entry will not be returned or acknowledged. Proof of entry is not considered proof of delivery to or receipt of such entry. PCEE shall have no liability for any submission that is lost, intercepted, or not received by PCEE for any reason.
